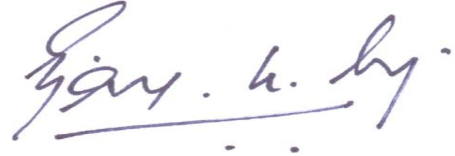

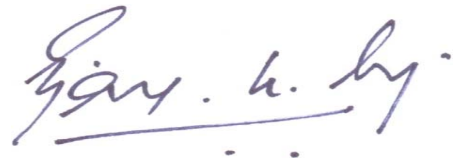

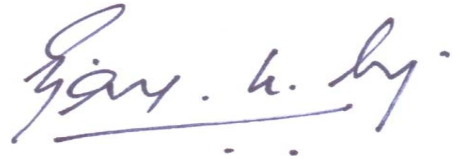

- I am not a Non- Independent Director of another Company on the Board of which any Non- Independent Director of the Company is an Independent Director.

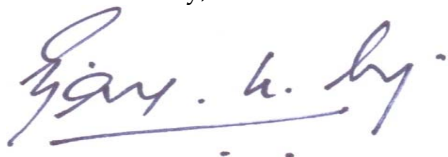

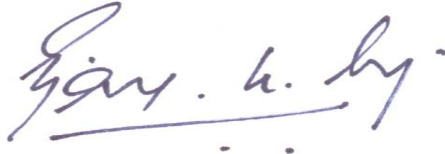

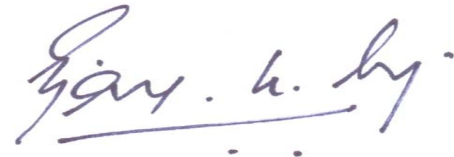
